The entrance to the testing site is at East State Fair across from Bauman Avenue. Testing hours for the drive-thru are 9 a.m. – 6 p.m.

Who can go: COVID-19 testing will be available by appointment to any resident of the tri-county region (Wayne, Oakland, and Macomb County). No prescription necessary.

Tri-County Residents: What You Should Know:

- Appointment is required before coming to the Fairgrounds.
- Must bring photo ID and proof of residency to appointment.
- No prescription is required.
- Call (313) 230-0505 to book your appointment.
- Accepted forms of proof of residency include:
- Driver's license
- State identification card
- City of Detroit Municipal ID Card (Detroit residents only)
- Passport, Military ID, Veteran ID or Consular ID

Under federal regulations, the city is required to bill insurance for any individuals tested who have insurance coverage. The fee to be billed, if insurance is available, for specimen collection is \$25 and \$56 for the lab test. Insurance coverage is not required for testing. If you do not have insurance, you will not be billed.
